

NASPGHAN FOUNDATION IN OFFICE MEMBER GRANT
Submission Deadline: July 2, 2015

This one year grant supports the development and implementation of prototype projects which focus on patient education in practice settings. The goal of this grant is to support the creation of prototypic concepts that will be potentially available and free of charge to be utilized by the NASPGHAN/APGNN community for patients' needs. Criteria for award selection include the general applicability of the project to any practice setting.

GRANT TERM AND STIPULATIONS

The Foundation will award up to two grants, each ranging from \$500 - \$2000 for a one year period. Additional monies are not available for indirect cost recovery. Any product created utilizing funds from this grant will be the property of NASPGHAN. If there are specifics of proposed product that do not allow for NASPGHAN ownership or would require partial ownership, these should be detailed in the grant application.

A complete financial statement and an end-of-the-year summary report are required. All publications resulting from work supported by the NASPGHAN Foundation must acknowledge support by the relevant funding mechanism. Once grantees are selected and notified of the Foundation award, he or she will be required to sign an agreement to share a summary of their report with the NASPGHAN/APGNN community.

ELIGIBILITY

NASPGHAN members in good standing (i.e. dues paid) and their clinical care teams (i.e. MDs, Fellows, Nurses, Nurse Practitioners, Physician Assistants, Dietitians, Psychologists, Social Workers). A NASPGHAN or APGNN member must be part of the group designing and implementing the prototype. **Only one submission per office can be accepted.**

Sample Prototypes:

- Establishing new models of community disease-specific support groups (social networking, community building, peer networks)
- Educational video on a specific topic (i.e. endoscopy preparation)
- Educational materials for treatment plan to facilitate success in treating children with chronic constipation
- Educational materials on self management / monitoring of chronic illnesses (IBD)
- Family or patient mentoring support for specific diseases
- Educational tools for self-management in a chronic disease
- Develop culturally appropriate educational materials on specific disease
- Relaxation module for children

REVIEW PROCEDURES

The NASPGHAN Clinical Practice Committee will review and rank applications. Members of the review panel will follow strict conflict of interest guidelines. Contact between the applicants with task force members regarding applications is strictly prohibited and will lead to potential disqualification.

- Objective and hypothesis
- Needs assessment
- Budget (\$500 - \$2000)
- How will the plan be implemented and by whom
- Target constituency
- Outcome measures
